During the September 9, 1981, LRC/GPO/HIS project status meeting, it was agreed that chapters, subchapters, parts, and similar units in the U.S. Code should be preceded by non-print composition codes. Subsequently, it was agreed that these composition codes consist of a bell-R followed by a two digit level number. On September 22, HIS proposed a scheme for assigning the R-code level numbers (Memorandum LS-57). Using LS-57 as a base, R-codes were assigned throughout the 1976 Main Edition and Supplement IV. The attached list contains all of the R-codes assigned during that exercise. We expect, however, that as the U.S. Code continues to evolve, additional R-code levels will be needed. When this occurs, we would very much appreciate it if you would contact us, so that a level number can be assigned consistent with our software needs.
